### First Address

Date: 20<sup>th</sup> June 2013

The Corporate Interface Team at SIBM Pune inaugurated Imperio 2013-14 with an address by **Mr. Dan Mittman, Managing Director & Global Chief Operating Officer, UBS Investment Bank.**

Mr. Dan Mittman delivered the inaugural address to the students of MBA-I and MBA-II on the global Mergers & Acquisitions environment, the factors that influence its trends and the emergence of hedge funds as important stakeholders in this landscape. Mr. Mittman also provided the students with valuable insights on how the M&A business has progressed in the recent past.

**Ms. Courtney Lala, Associate Director, UBS Investment Bank**, then highlighted the aspects of Operational Risk in investment banking, and the measures that UBS Investment Bank is undertaking to mitigate the same.

Mr. Mittman is the Managing Director & Global Chief Operating Officer of UBS Investment Bank's Mergers & Acquisitions Group. He is also responsible for overseeing the investment bank's offshoring and outsourcing activities related to investment banking analytics and presentation services.

Prior to joining UBS Investment Bank in November 2000, Mr. Mittman was First Vice President and Senior Associate General Counsel of PaineWebber's Investment Banking Division. Prior to joining Paine Webber in 1996, he practiced corporate and securities law at Latham & Watkins in New York.

Mr. Mittman received his J.D. from the University of Miami School of Law, and B.S. in Accounting from Brooklyn College.

'**Arcturus2013: The Leadership Conclave**', organised by CIT, centered around the theme of '**Crisis Management & Strategy**'. It served as a platform that brought together leaders who are at the forefront of various organisations, to share their experiences and the challenges of business management in their respective industries. The objective of this symposium was to analyse and

understand how organisations cope with times of uncertainty, how businesses overcome crises, and what strategies define India Inc. in 2013.

The inaugural address was delivered by **Mr. Prakash Iyer (Managing Director | Kimberly Clark Lever Pvt. Ltd.)**. A brilliant orator and a successful author, Mr. Iyer spoke about the importance of hope and perseverance during a crisis, and gave the audience some very valuable lessons on how one's basics and fundamentals become crucial in these times. The Keynote Address was then delivered by **Mr. D. Shivakumar (Former Senior Vice-President, India, Middle East and Africa Region | Nokia Corporation)**. Mr. Shivakumar gave wonderful examples to show how industries cope with crises, and what the different kinds of crisis scenarios could be. The morning session was concluded by **Mr. Piyush Mathur (President, India Region | Nielsen)**. Mr. Mathur brought to light the audacity of hope, and gave the audience a reason to believe that all was not lost. He also brought in insights about how Nielsen itself is dealing with this crisis, and is holding on to its growth story.

The afternoon session began with an address by **Mr. Lalit Malik (Chief Financial Officer | Dabur India Ltd.)**, who addressed the audience with respect to how Dabur and other FMCG organisations are impacted by this move. He also gave us insights into the financial aspects of status quo, and what the government can do to bring India out of this crisis. The next address was by **Mr. Arun Mehra (Chief Executive Officer | Talenhouse India)**. Mr. Mehra had a very unique and interesting perspective to crisis management, wherein he took us through his own story and the various crises that he faced, to show the audience as to how much a crisis can potentially teach you and help you grow.

The closing address at Arcturus 2013 was by **Mr. Bhavook Tripathi (Stock Markets Investor)**, who is arguably the youngest Indian billionaire investor. Mr. Tripathi took the audience through the major financial reasons for this crisis, and gave us his unique insight of how India should follow its own cultural path towards growth. Mr. Tripathi shared with the audience his dream of India becoming the best 'karmabhoomi', so as to enable sustainable, valuable economic growth in the future.

With a plethora of valuable industry insights, very inspirational addresses, and interactions with some of the best minds in the industry today, Arcturus 2013: The Leadership Conclave was a grand success. The sessions enabled participants to gain first-hand industry opinions, and encouraged them to delve deeper and analyse today's economic scenario, thus providing a truly wonderful platform for the students on SIBM Pune.
